

Article 4(2) Direction Notice

Brecon Beacons National Park Authority

Town and Country Planning (General Permitted Development Order 1995 (As Amended)

Notice is hereby given that the Brecon Beacons National Park Authority has made the Directions under Article 4(2) of the Town and Country Planning (General Permitted Development) Order 1995 (As Amended). These Directions apply to land and buildings within the Talgarth Conservation Area as set out in Schedule 1 of this Notice and came into force on 5th July 2016 have now been confirmed on 9th December 2016.

The effects of these Directions is that the permission granted by Article 3 of the General Permitted Development Order 1995 (as Amended) shall not apply to the types of development listed below where works affects an elevation facing a highway, waterway or open space. This does not mean that the types of development listed below cannot take place only that planning permission must be sought.

The types of development that require planning permission as a result of the Article 4 (2) Direction are as follows; the enlargement, improvement or other alteration of a dwellinghouse; the insertion, blocking, alteration of an opening; the insertion, removal, alteration or replacement of windows and doors; the erection, removal, alteration or addition of any other architectural feature; the painting or rendering of the exterior (where it is not currently painted or rendered); the erection, removal, alteration or replacement of gates, fences, walls and other means of enclosure; the formation of hard standing.

Schedule 2

Town and Country Planning Act 1990 Part III Section 55

'Meaning of "development" and "new development".

(1) Subject to the following provisions of this section, in this Act, except where the context otherwise requires, "development," means the carrying out of building, engineering, mining or other operations in, on, over or under land, or the making of any material change in the use of any buildings or other land

(1A) For the purposes of this Act "building operations" includes-

- (a) Demolition of buildings;
- (b) Rebuilding;
- (c) Structural alterations of or additions to buildings; and
- (d) Other operations normally undertaken by a person carrying on business as a builder.

General Permitted Development Order 1995

Class A Part 1 of Schedule of said order:

The enlargement, improvement or other alteration would front a highway, waterway or open space

Class D of Part 1 of Schedule 2 of the said Order:

The erection or construction of a porch outside any external door of a dwellinghouse, where the external door fronts a highway, waterway or open space

Class F Part 1 of schedule 2 of said Order:

The provision or replacement in whole or part within the curtilage of a dwellinghouse of a hard surface where the hard surface would front a highway, waterway or open space

Class A of Part 2 of Schedule 2 of the said Order

The erection, construction, maintenance, improvement or alteration of a gate, fence, wall, or other means of enclosure within the curtilage of a dwelling house where the gate, etc., would front a highway, waterway or open space

Class C of Part 2 of Schedule 2 of the said Order

The painting of the exterior of any part of a dwellinghouse or of a building or enclosure within the curtilage of a dwellinghouse where the exterior fronts a highway, waterway or open space.

Class B of Part 31 of Schedule 2 of the said Order

The demolition of a gate, fence, wall or other means of enclosure within the curtilage of a dwellinghouse where the gate etc., fronts a highway, waterway or open space
