RHODDIR DRWY HYN RYBUDD y bydd y Gorchymyn uchod a wnaed gan Awdurdod Parc Cenedlaethol Bannau Brycheiniog ar yr 18^{fed} o Ebrill, 2019 a oedd i ddod i ben ar yr 18^{fed} o Hydref, 2019 yn parhau i fod yn weithredol gyda chymeradwyaeth Gweinidogion Cymru tan ac yn cynnwys y 17^{eg} o Ebrill, 2020. Effaith y Gorchymyn yw i wahardd cerddwyr rhag myned ar hyd llwybr troed rhif 5 yng Nghymuned Llanfrynach, Powys sydd yn rhedeg am bellter o oddeutu 275 metr i gyfeiriad y de orllewin a'r gorllewin de orllewin o gyfeirnod grid 303171,218085 i'r dwyrain o Gronfa Neuadd Isaf i gyfeirnod grid 302937,217977 i'r gorllewin o Gronfa Neuadd Isaf.

Road Traffic Regulation Act 1984: Section 14 (1)
Brecon Beacons National Park Authority (Footpath No. 5 in the Community of Llanfrynach) (Temporary Prohibition of Pedestrians) Order 2019

NOTICE IS HEREBY GIVEN that the above named Order made by the Brecon Beacons National Park Authority on the 18th April, 2019 and which was due to expire on the 18th October, 2019 has been continued in force with the approval of the Welsh Ministers until and including the 17th April, 2020. The effect of the Order is to prohibit the passage of pedestrians in the length of public footpath no. 5 in the Community of Llanfrynach, Powys which extends for a distance of 275 metres or thereabouts in south westerly then west south westerly direction from grid reference 303171,218085 to the east of Lower Neuadd Reservoir to grid reference 302937,217977 to the west of Lower Neuadd Reservoir.

The purpose of the Order is to ensure public safety while essential work is being carried out at Lower Neuadd Reservoir.

No alternative routes are available via the rights of way network but there is an alternative route signed on site.
